- In the case of joint holders, the vote of the senior who tenders a vote, whether in person or by proxy, will be accepted to the exclusion of the vote(s) of other joint holder(s), and for this purpose, seniority will be determined by the order in which the names stand in the register of members of the Company. 7.

Any shareholder entitled to attend and vote at the AGM is entitled to appoint one or more than one proxy to attend and, on a poll, vote instead of him/her. The proxy need not be a shareholder of the Company but must attend the AGM in person to represent you. 9.
